Data protection

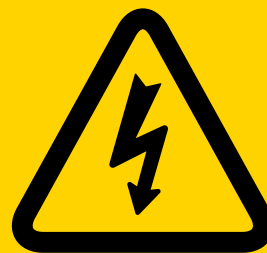
